It analyses the European Union's policies towards, and the impact they have, upon the states of the Western Balkans, and assesses how these affect the nature of EU foreign policy. To this end, it focuses on the tools and mechanisms that the EU employs in its enlargement policy and examines the new instruments of direct intervention (in Bosnia and Kosovo), political coercion (in the case of Croatia and Serbia in relation to the International Criminal Tribunal for the former Yugoslavia), and stricter conditionality in the Western Balkan countries. Title **Description/Preview Availability** The long march towards the EU: Seven consecutive enlargements, spanning over **Online** article candidates, neighbours and the half a century, have provided geopolitical stability in prospects for enlargement Europe and facilitated trade and economic growth. The rationale for they share a future? denying EU accession differs for each country, but the underlying reservations are identical: yet "not Eran Fraenkel prepared"; "too early" to accept a new country; or 2016 the "cost" of admitting a new member outweighs any benefits that might derive from its accession. The author call for stronger engagement of the EU in the accession process, based upon mutually agreedupon accession benchmarks. The aim of this policy paper is to assess the current EU enlargement to the Western state of play in the process of EU enlargement to Online article Balkans: out of sight, out of mind? the Western Balkans. It examines ways of Marko Stojić accelerating the process, asking the question whether the EU and the Commission in particular 2016 possess appropriate tools to deal with the 'complicated' candidate countries in a complex international reality. The paper argues that, although the recent changes in the Commission's approach to candidate countries are positive, there is more to be done to re-energise the process and encourage domestic reforms in these countries.
